HealthforAnimals active for antibiotics



Review on Antimicrobial Resistance

Tackling drug-resistant infections globally

May saw HealthforAnimals issue two press statements on the topic of antibiotics following the publication of the "[Review on Antimicrobial Resistance – final report](#)" by Lord O'Neill and ahead of the G7 summit taking place in Japan. In June, the association also published a joint position paper on antibiotic use and resistance in agriculture, which was presented at the 39th session of the Codex Alimentarius Commission (CAC) meeting in Rome.

The position paper was produced by the Private Sector Mechanism and the International Agri-Food Network (IAFN), an informal coalition of 13 international trade associations involved in the agri-food sector at the global level, which represent tens of thousands of companies, cooperatives and millions of farmers. The global animal health industry has been very [active on the issue of antimicrobial resistance](#) and welcomes efforts to curb the development of antibiotic resistance. The association does raise concerns however that some proposals to tackle the issue are driven by political considerations rather than scientific reality and warns policy-makers of the potential impact on animal health and welfare that a ban on using antibiotics in veterinary healthcare could bring.

Global benchmarking survey findings published



HealthforAnimals has just published the results from its global survey benchmarking the animal health industry worldwide. Since 1996 HealthforAnimals has benchmarked the status of regional regulatory frameworks for veterinary medicines and this latest survey, now extended to two further regions, received a total of 79 responses from across Europe, USA, Australia, Japan, China and Brazil.

Findings show that although progress has been made within the industry in some areas,

common barriers to innovation in animal health remain. In the face of global health challenges such as antimicrobial resistance (AMR) the survey shows that increased co-operation on a global level will be required to drive innovation in the animal health sector.

First ever World Animal Vaccination Day launched

Raising awareness of the vital role vaccines play in protecting the health of animals and, as a result, people too, this initiative will each year focus on a different theme. The inaugural World Animal Vaccination Day highlighted the need for cat vaccination and keeping their vaccines up to date. This was illustrated with the positive fact that, thanks to widespread vaccination, less than 1-2% of healthy cats in the world have feline leukaemia.
