

Kristin Peck Selected to Lead HealthforAnimals, Global Animal Health Association, as New President

The Zoetis CEO will lead the organization and sector for the next two years

14 March 2022 – Last week, Kristin Peck, Chief Executive Officer of Zoetis, was selected by her peers in the Animal Health sector to serve a two-year term as President of HealthforAnimals. HealthforAnimals' Members represent approximately 90% of the global market for veterinary pharmaceuticals, vaccines, diagnostics and other animal health products worldwide.

Ms. Peck was unanimously selected by her fellow CEOs on the Board of Directors and Animal Health representatives from across the world in the Association's General Assembly. She takes over the position from Marc Prikazsky, Chairman and CEO of Ceva Santé Animale who served from February 2020 to March 2022.

She is also a member of the Business Roundtable, a Board member of Catalyst, a global non-profit that helps companies around the world accelerate women into leadership, and sits on the Board of BlackRock, the world's largest asset management firm.

Ms. Peck will now serve as HealthforAnimals President for two years (March 2022 - March 2024), where she will help guide the Association during a time where animal health is at the top of the global agenda and One Health is better recognized than ever before.

"I thank my fellow Board Members and the wider Membership of HealthforAnimals for entrusting me with this position," said Ms. Peck. "The role of animal health has never been more essential and evident in society than it is today. Whether it is the pet in our home or the livestock in the field, animals are deeply intertwined in our lives. Some of the world's toughest challenges, from zoonotic disease to sustainability, require strengthening animal health, and it is an honor to further support this effort as HealthforAnimals President."
